Mr. Ole Stage has more than 30 years of working experience with international development.

Good governance and civil society development: Mr. Stage has experience from working with various aspects of governance, he has worked with support to local government institutions and municipalities (supply of governance) as well as with civil society development (demand for governance). He has thorough experience from establishing, implementing and assessing programmes for supporting civil society development. In addition to the more than 30 assignments he has undertaken for NGOs the following key assignments could be mentioned: He implemented a major programme for supporting civil society organisations in Palestine and Israel in 2006 - 2007. In 2007 he evaluated EU's programme for support to civil society in South Africa. In 2009 he formulated the Danish NGO, Ibis, programme in West Africa, which was focussed on civil society development and good governance. 2010 – 2011 he conducted an evaluation of EU's programme to Human Rights and Good Governance in Uganda. In 2016 he conducted an evaluation of programme-based support to Finnish CSOs.

From the supply side of governance he has designed and implemented programmes supporting local authorities (Mozambique 2003 – 2007 and 2014 and Uganda 2011 – 20012). Many of his assignments have combined the supply

and the demand sides by linking civil society and local authorities by creating platforms for dialogue (examples of this are Ghana (2000), East Africa (2007), West Africa (2008), Ghana (2014 and 2016) and Mozambique (2016 and 2017-18)

Organisational development and capacity building: Mr. Stage has thorough experience in providing support for institutional development and organisational strengthening of civil society organisations – international and national NGOs as well as CBOs (from Palestine, South Africa, Mozambique, Finland and Denmark). He has furthermore undertaken a number of organisational analyses and capacity assessments of NGOs and CBOs: Ghana Friendship Groups in 2001 and in 2009; Danish Centre for Human Rights in 2001-02; Danish Refugee Council in 2005; AXIS in 2009; FIC in 2012 and Dansk Folkehjælp in 2013.

He has experience with organisational management, administrative systems and procedures for civil society organisations from implementing a major programme for organisational strengthening in Palestine, from assessing EU supported human rights programmes of civil society organisations in South Africa and Uganda, and from supporting a number of programmes of Danish NGOs.

Evaluation: Mr. Stage is an experienced evaluator who has undertaken a wide range of evaluations and reviews within different fields. He has conducted more than ten major evaluative studies and a number of evaluative studies of projects. In 1999 he headed the evaluation of Danish humanitarian assistance to Angola. In 2002-3 he was a core member of the evaluation of the joint donor agricultural sector programme PROAGRI in Mozambique. In 2003 he headed the evaluation of Norwegian Refugee Council's programme in Angola. In 2006 he led the evaluation of the FAO's programme in Mozambique. In 2005 he was team leader for an evaluation of Sida's support to General Statistics Office in Vietnam and in 2009 he did a similar evaluation of Sida's support to Department of Statistics in Laos. In 2007 he led the evaluation of the Human Rights Foundation in South Africa. In 2007-8 he was deputy team leader of the evaluation of the Danish country programme to Benin. In 2011 he headed the Mid-term Review of Peace, Reconciliation and Development Plan for Northern Uganda. In 2014-15 he was team leader for an evaluation of the SNV school garden project. 2015 – 16 he was the team leader of the evaluation of programme-based support through Finnish SCOs where he also headed two of the field studies (of the Fair-Trade programme in Central America and the Finnish Refugee Council in Uganda and Sierra Leone).

Monitoring: Mr. Stage is methodologically oriented and has a wide experience from applying qualitative as well as quantitative tools. He has organised national statistical surveys (Mozambique 1980-81 and The Gambia 1991-94), however he has also collected qualitative data in rural areas based on participatory methods and data on behavioural change based on Most Significant Change and other outcome-oriented methods. He has applying these skills in developing M&E systems for a wide range of programmes that often have combined quantitative and qualitative data: Results-based monitoring systems for Danish country programmes (2004); programme of Centre for Conflict Resolution at University of Cape Town (2002 - 05); results-based framework for Palestinian and Israeli human rights organizations (2006); the Uganda Peace, Recovery and Development Plan including establishment of civil justice system and local systems for conflict management (2011 – 12); business sector support programme in Ghana (2015). He undertook a study of the M&E systems of the 22 Finnish CSOs receiving programme-based support in 2015 – 16, and in 2017 he assisted Danish Outdoor Council and its African partners to set up an M&E system based on Outcome Mapping and Outcome Harvesting.
